I. Personnel Cost

I.A. General Overview

Personnel cost¹ decreased by LL 309 billion (4.7 percent) year-on-year during Jan-Aug 2021 to reach LL 6,231 billion compared to LL 6,540 billion during the same period of 2020². This drop was due to a considerable year-on-year drop in the salaries, wages and social benefits by LL 237 billion (5.8 percent), end of service indemnities by LL 94 billion (35.2 percent) and transfers to Public Institutions to cover salaries by LL 24 billion (8.1 percent). In contrast, the payments related to retirement compensations witnessed a year-on-year rise by LL 46 billion (2.4 percent).

I.B. Share of Personnel Cost from Expenditures

Personnel cost constituted the main bulk of the current primary expenditures³ as it contributed to 73.1 percent in Jan-Aug 2019, before shrinking to 71.5 percent in Jan-Aug 2020, and hiking up again to 72.4 percent during Jan-Aug 2021⁴. Compared to total expenditures, personnel cost averaged 41.7 percent of total expenditures during Jan-Aug 2019, rising to 50.0 percent during Jan-Aug 2020, before hiking up to reach 53.1 percent during Jan-Aug 2021. The main reason behind the significant increase in the personnel cost as a share of total



expenditures in 2020 and 2021 lies in substantial changes in the expenditure base registering considerable year-on-year drops of 18.5 percent and 10.4 percent during Jan-Aug 2020 and Jan-Aug 2021 respectively.

The following figures represent the composition of total expenditures and current primary expenditures during Jan-Aug 2021:

II. Salaries, Wages, and Related Benefits

Payments for salaries, wages and related benefits decreased significantly by LL 237 billion year-on-year to reach LL 3,846 billion⁵ in Jan-Aug 2021. Overall, this was mainly due to a significant decline in total "allowances" by LL 182 billion (30.0 percent), as those paid to the Army and the Internal Security Forces decreased by LL 127 billion (35.9 percent) and LL 57 billion (28.2 percent) respectively. In addition, "employment benefits" dropped by LL 15 billion (11.7 percent), resulting from a decrease in payments for the education and civilian personnel by LL 12 billion (37.7 percent) and LL 8 billion (24.5 percent) respectively, against a LL 5 billion (6.8 percent) hike in payments for military personnel.

In parallel, payments covering "salaries and wages" decreased by LL 33 billion (1.1 percent), with a decrease in payments for the education and civilian personnel by LL 37 billion (5.2 percent) and LL 6 billion (1.7 percent) respectively. These drops were slightly offset by a LL 9 billion rise in the amounts paid to the military personnel mainly due to a hike of LL 17 billion (3.3 percent) in those paid to the Internal Security Forces.

In terms of composition, "salaries and wages" constituted 78.7 percent⁶ of total payments for salaries, wages and related benefits to public sector employees in Jan-Aug 2021, followed by "allowances" (11.0 percent)⁷ and "employment benefits" (3.0 percent), while "other payments" and "unclassified allowances" represented the remaining 7.3 percent of the total.

Furthermore, salaries, wages and related benefits increased as a share from total primary spending from 37.2 percent in Jan-Aug 2020 to 39.0 percent in Jan-Aug 2021.



II.A. Salaries and Wages

Salaries and wages of public sector employees, excluding indemnities, allowances and other benefits, decreased by LL 33 billion (1.1 percent) year-on-year to reach LL 3,027 billion in Jan-Aug 2021. This was driven by the LL 37 billion (5.2 percent) decrease in salary payments for the education personnel and by LL 6 billion (1.7 percent) drop in payments to the civil personnel.

II.A.a. Salaries and Wages of Military Personnel

Salaries and wages of the military personnel increased by LL 9 billion (0.5 percent) in Jan-Aug 2021 compared to the same period of 2020. In details, salaries and wages paid to the Internal Security Forces increased by LL 17 billion (3.3 percent), driven by the LL 21 billion hike in payments related to clothing over the covered period. As for the salary payments to the General Security Forces, Army and the State Security Forces, they decreased by LL 4 billion (2.6 percent), LL 3 billion (0.2 percent) and LL 1 billion (1.3 percent) respectively.

II.A.b. Salaries and Wages of Education Personnel

Salaries and wages of the education personnel decreased by LL 37 billion (5.2 percent) year-on-year and stood at LL 669 billion in Jan-Aug 2021. The main driver for this drop was the considerable decrease to both permanent personnel and contractuals at the primary education by LL 25 billion and LL 7 billion respectively.

II.A.c. Salaries and Wages of Civilian Personnel

Salaries and wages to the civilian personnel decreased by LL 6 billion (1.7 percent) year-on-year, to reach LL 329 billion in Jan-Aug 2021. At the level of the ministries, the Ministry of Foreign Affairs and Emigrants (MoFA) represented the largest wage bill during the covered period, with a share of 16.9 percent from total salaries and wages paid to the civilian personnel, followed by the Ministry of Justice (16.3 percent from total) and the Ministry of Finance (12.4 percent from total). In details, employees at the Ministry of Foreign Affairs and Emigrants witnessed a year-onyear drop in salary expenditures by LL 2.0 billion (3.5 percent), as payments covering salaries of permanent personnel declined by LL 3.6 billion.

II.B. Payment of Allowances

The cumulative payment of allowances to public sector employees decreased significantly by LL 182 billion (30.0 percent) to reach LL 424 billion in Jan-Aug 2021. This drop was mainly due to a LL 127 billion drop in allowances paid to the Army to reach LL 228 billion and a LL 57 billion decrease in allowances disbursed to the Internal Security Forces reaching LL 145 billion in Jan-Aug 2021.

In details, allowances paid to the Army witnessed a sharp drop of LL 127 billion (35.9 percent) as hospital expenses drastically decreased year-on-year by LL 149 billion (68.9 percent), despite a LL 25 billion (28.4 percent) rise in school allowances.

In addition, allowances paid to the Internal Security Forces dropped by LL 57 billion (28.2 percent), with respective declines of LL 37 billion (34.0 percent), LL 9 billion (14.8 percent) and LL 7 billion (41.7 percent) in hospital expenses, school allowances and sickness and maternity expenses, over the covered period.

As for the allowances paid to the General Security Forces, they slightly increased by LL 2 billion (5.3 percent) in Jan-Aug 2021 compared to Jan-Aug 2020, with respective increases in payments covering treatments in different medical centers and school allowances by LL 2.5 billion and LL 0.9 billion respectively.

Lastly, allowances paid for the State Security Forces declined by LL 1 billion over the covered period, mainly as hospital expenses decreased by LL 0.8 billion compared to the same period last year.

II.C. Government subscription and contributions in the Employees Cooperative

Payments covering the government subscription and contributions to the Employees Cooperative fixed to LL 196 billion and stayed unchangeable in Jan-Aug 2021 when compared a year earlier.
